Listed below are certain requirements and information concerning the application for participation at Kaboom Town! These requirements are not all inclusive and the information is subject to change without notice.

- ! Kaboom Town Vendor applications may be submitted for approval until **Monday, April 3, 2017**. Applications not received by the designated deadline date, will not be considered. Submission of the application does NOT guarantee admittance into the event. You will be notified in writing confirming the selection or denial of your application. Notification will take place by Monday, April 17, 2017.

- ! Vendors are chosen based on a number of variables, including but not limited to: the uniqueness of the food product, the availability of space, past experience, and the needs of Kaboom Town! If you are selected and an agreement is signed:
 - ! Vendor may sell food and specialty drink items only. NO alcohol or Coca-Cola product may be sold.

 - ! Concessionaire will collect 35% of gross sales after the event. All Vendors are required to accept any Addison Tasty Bucks (tickets valued at \$1.00 each) and submit them for reimbursement to the Concessionaire.

 - ! Vendor must have an auditable POS system in place for the event. Square Stand or a drawer with tape feed are required in order to prove legitimacy of sales.

 - ! Vendor must provide proof of the following insurance coverage that has been purchased at its own expense. Insurance must name Taste of Cuba Food Truck and Catering, LLC as an additional insured and contain a waiver of subrogation endorsement in favor of Taste of Cuba for the period of time listed as July 2-4, 2017.
